PERSONAL IMPACT...

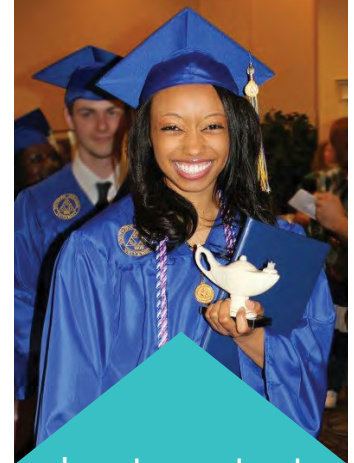
